VENTURA, KERJASAMA DAN ALUMNI (VKA)

1. **Highlight Activity Venture, Partnership and Alumni Unit**

2020 is a year full of challenges. Big challenges faced together, including the challenges faced by the Venture, partnership and Alumni (VKA) unit, FEB UI. One of these challenges began with the enactment of the restriction policy, due to the Covid-19 pandemic, both by the campus and the Indonesian government since March 2020 until now.

The restriction policies that have been carried out, especially at UI and FEB UI, have had a great impact on VKA, because VKA is closely related to non-BP (revenue from other than fee tuition fee) funding sources for FEB UI. This condition causes more limited sources funding for VKA.

In order to fulfill the condition VKA has collaborate with some government institutions this year. The partnership with government are National Development Planning Agency (Bappenas), central statistics bureau (Badan Pusat Statistik), PT. PLN (Persero) Tbk, BPH Migas, Minister of Finance (Kementerian Keuangan). FEB UI has partnership with BUMN. There are PT. ASDP Indonesia, PT. Pegadaian (Persero), PT. Pertamina Gas dan PT. Bank Rakyat Indonesia (Persero) Tbk.
