ADMISSION REQUIREMENT

- Graduated from an Indonesian high school approved by the Ministry of National Education (Kemendikbud) or have a UN high school certificate; or, Graduated from an Indonesian/International/foreign high school with a cumulative of 12-year of primary and secondary schooling with the following scheme sequence of primary – junior high – senior high: 6-3-3; 6-4-2; 5-3-4; 4-4-4 ; or, Passed the “Kejar Paket C” (Indonesian High School Certificate Equivalent Test) for those who do not meet any of the criteria mentioned above.
- Have a minimum TOEFL score of 173 (CBT), 61 (iBT), 500 (PBT) or IELTS score of 5.5. or EPT LBI UI score of 500.

Degree:

Sarjana Ekonomi from Universitas Indonesia and Bachelor Degree from Partner University, majoring in Economics, Management, Accounting and Islamic Business.

Credits:

A total of 144 required credits accumulated from FEB UI and Partner University.

Normal study of 4 years for Bachelor Degree (Sarjana), with schemes:

- 2 years in IUP FEB UI + 2 years in Partner University;
- 2.5 years in IUP FEB UI + 1.5 years in Partner University;
- 3 years in IUP FEB UI + 1 years in Partner University.


ADMISSION AND TUITION FEES

These amounts are subject to annual review and may change accordingly.

- **Admission Fee, upfront charge or one-time charge:**
Rp. 40,000,000 for Indonesia Citizen
Rp. 60,000,000 for Foreign Citizen
- **Tuition Fee per semester:**
Rp. 29,300,000 for Indonesia Citizen
Rp. 29,300,000 for Foreign Citizen

ADMISSION PROCEDURE

- **International Online Application:** Administered through admission.ui.ac.id, requiring submission of documents and an interview test, specifically designed for foreign citizens interested in studying at IUP-FEB UI.
- **Talent Scouting:** Direct admittance procedures to IUP-FEB UI based on a student's high school academic performance. Registration process is conducted by the principal of the school. Only selected high schools participate in the talent scouting program.
- **SIMAK KKI:** Administered through Seleksi Masuk Kelas Khusus Internasional (SIMAK KKI) with exam materials including:
 - Basic Mathematics
 - English
 - Logic
 - Quantitative Reasoning



Admission Fee Rp. 40,000,000 X 1 = Rp. 40,000,000
